

Did you know that any gift made to Child & Family Resources is eligible for the **Arizona Charitable Tax Credit**? This means you can potentially receive tax benefits while supporting a great cause. Our tax ID is **#86-0251984**. Our QCO code is 20343.

Individual filers can claim up to **\$470**, and joint filers can claim up to **\$938** in total contributions to qualifying organizations. By donating to Child & Family Resources, you're not only helping your community but also making the most of your tax benefits!
